ORDINANCE NO.

**AN ORDINANCE SETTING COMPENSATION OF TOWNSHIP
SUPERVISORS IN ACCORDANCE WITH THE SECOND CLASS
TOWNSHIP CODE.**

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania has enacted the Second Class Township Code, Act of May 1, 1933, P.L. 103, No. 69, and the amendments thereto, and Act 94 of 2024, (53 P.S. 65606), setting forth certain guidelines and limitations on the compensation of Supervisors of Townships of the Second Class; and

WHEREAS, the said Act 94 of 2024 categorized the said compensation on the basis of Township population to the extent that the Supervisors of Townships having a population of from 5,000 through 9,999 people shall be compensated in an amount not to exceed Four Thousand One Hundred Ninety (\$4,190.00) Dollars per year; and

WHEREAS, the population of Bushkill Township is in excess of 5,000 and less than 9,999 as of the date hereof; and

WHEREAS, the said Acts authorize the Board of Supervisors of the various Townships of the Second Class in the Commonwealth of Pennsylvania to enact, by Ordinance, the compensation of its Supervisors as more fully set forth below; and

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Township of Bushkill, by and through its Board of Supervisors, and IT IS HEREBY ENACTED AND ORDAINED by the authority of the same and the Act of May 1, 1933, P.L. 103, No. 69, and the amendments thereto, and Act 94 of 2024, as follows:

SECTION 1: Each Township Supervisor of Bushkill Township taking office on or after the effective date of this Ordinance shall receive compensation for attending duly advertised general or special public meetings or hearings of the Board of Supervisors, or other meetings authorized by the Board of Supervisors, in the annual amount of Four Thousand One Hundred Ninety (\$4,190.00) Dollars.

SECTION 2: Such compensation shall be paid in monthly or quarterly installments.

SECTION 3: This Ordinance shall become effective five (5) days after enactment.

SECTION 4: No Township Supervisor of Bushkill Township shall receive compensation under this Ordinance for the performance of duties as set forth in Section 1 hereof in excess of the annual statutory limit set forth in Act 94 of 2024.
